

## **Additional Information for State Income Tax Purposes**

The ResCap Liquidating Trust (the “Trust”) has recently completed filing income tax returns for the period 12/17/2013 through 12/31/2013 in those states in which the Trust has determined that it had a filing obligation, based on the Trust’s property, payroll or other connections with the states.

Attached to this letter are 2013 Tax Worksheets for Beneficiaries of ResCap Liquidating Trust Units for the Period 12/17/2013 through 12/31/2013 for each of the states in which the Trust filed an income tax return. These Worksheets reflect the income and deductions that the Trust determined should be allocated to each state in which it filed an income tax return.

Unitholders (“Beneficiaries”) must make their own determination as to which state income tax returns, if any, they are required to file as a result of their ownership of Trust Units or otherwise, and their share of Trust income and deductions, if any, that must be reported on any such state income tax return.
